

ORLANDO SENTINEL'S NEW SMYRNA BEACH WEEKEND GETAWAY SWEEPSTAKES OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** The Orlando Sentinel's New Smyrna Beach Weekend Getaway Sweepstakes (the "Promotion") is sponsored by Orlando Sentinel Communications Company LLC ("OSC") and Southeast Volusia Advertising Authority, 2238 State Road 44, New Smyrna Beach, Florida 32168 ("Promotion Parties"). Promotion is offered only in the following Florida counties: Orange, Osceola, Volusia, Flagler, Lake, Polk, and Seminole ("Promotion Area"). Void outside Promotion Area and where prohibited.
2. OSC will be entitled to interpret these Official Rules — including but not limited to rules regarding entries, deadlines, winner selection, prize restrictions, and eligibility — and all of its decisions are final. By entering, entrants agree to these Official Rules.
3. Promotion begins on June 7, 2015 at 12:01 a.m. Eastern Time ("ET") and runs through June 28, 2015 at 11:59 p.m. ("ET"). OSC's computer is the official time-keeping device for this Promotion.

ELIGIBILITY

4. To be eligible, each entrant must be at least (21) years old and a legal resident of the Promotion Area (above) as of date of entry.
5. Employees of OSC, Southeast Volusia Advertising Authority and the Hampton Inn New Smyrna Beach, and the members of their immediate families (defined as spouse, parents, siblings or children) and households, are not eligible to enter or win. TO ENTER

SELECTION, NOTIFICATION AND VERIFICATION OF WINNERS

11. On June 29, 2015, or within a reasonable time thereafter, OSC or its designee will randomly choose one (1) name from all timely entries received. Subject to verification of eligibility, the first person whose name is so drawn will be declared the Grand Prize winner.
12. OSC will contact potential winner in accordance with the information supplied to OSC on his or her official entry form. PRIZE
